# FAIRFIELD WASTEWATER TREATMENT PLANT HARDENING PROJECT

## A CASE STUDY FOR PROTECTING A CRITICAL FACILITY

CAFM is pleased to host Jonathan Richer, PE of Tighe & Bond and representatives from the Town of Fairfield, Connecticut for a Tour and Lunch & Learn event featuring the Fairfield Wastewater Treatment Plant (WWTP) Hardening Project. In the aftermath of Hurricane Sandy, portions of the plant and surrounding facilities were submerged in up to two feet of water due to the coastal storm surge from Long Island Sound. The Town utilized newly created funding sources through HUD and CTDOH to design and construct a flood control structure and pump stations that will protect the WWTP and surrounding critical Town facilities from a 0.2% Annual Chance (500-Year) flood event. The project required permitting through several Federal, State, and local entities including HUD, USACOE, CTDEEP and the Town of Fairfield. A guided tour of the WWTP improvements will be followed by lunch and a formal presentation at the adjacent Fairfield Regional Fire School.
